


Subject: Guidelines to ensure effective utilization of IFPDs in 418 Schools under ICT Phase-III.

Sir,

This is in reference to implementation of ICT Phase III under which two IFPDs along with content from grades 6th to 12th has been provided to 418 Schools. To ensure effective utilization of IFPDs the following **usage and maintenance guidelines** are to be shared with all schools are reiterated below for strict compliance:

1. Minimum Usage:

All teachers must use IFPD devices for a minimum of 2 periods per grade and per subject per week. Healthy usage is defined as at least 10 to 12 minutes during every class.

2. Time Table: HMs to ensure that timetable is created in all 418 schools to ensure IFPDs are used for 2 periods per subject for the subjects of Maths and Science for grades 6th to 9th

3. Lesson Plan Integration:

Teachers must integrate IFPD digital content with their lesson plans to enhance classroom teaching and improve student learning outcomes.

4. Weekly Syncing of Devices:

All IFPD devices must be synced by ICT Instructor at least once every week to ensure proper updates and functionality.

5. Monitoring During Visits:


Usage and functionality of IFPD devices shall be checked and monitored by DPOs and Deputy Directors during their school visits to ensure proper use and integration.

The guidelines must be reiterated and explained during the upcoming ICT Phase III trainings to ensure that teachers are using the devices regularly.

Further, you are instructed to **review the Usage Dashboards available on the VSK portal at least once every 15 days** to monitor the usage trends of schools in your respective districts and take necessary action for schools showing low or no usage.

Your immediate action in this regard is imperative.


