## Notes on Accounts

- 1 The Financial Statements have been prepared for funds received / utilized for the project Samgra Shiksha and all other Schemes. All the unutilized grants at BRCC and school level have been transferred to SNA A/C at the end of the year.
- The expenditure incurred on various heads of accounts e.g. Salary paid to Staff, Printing & Stationery, Telephone, Electricity, Travelling, Conveyance Expenses etc. have been debited to Management Cost and head wise bifurcation have not been done at most of the Districts. Level.
- 3. The physical verification of the fixed assets / stores has not been carried out during the year under audit. The fixed asset register was not maintained by the district and State Project office. Hence the value, location of fixed assets remains unverified. The project has also not identified unserviceable, absolute and condemned assets. Efforts should be initiated for the physical verification of fixed asset lying at various locations of the project and also for the identification of asset not in use, absolute assets and condemned assets.

4. Internal audit of SMCs and school was also not conducted and UC were issued by DPOs on basis of which expenditure was booked. However in the absence of proper internal audit of the same, these UCs are subject to confirmation.

5. Audit Of SMC:- The audit of various SMC's at the BRC'S level is under process and its reports shall be submitted separately.

6. Current Assets, Loan & Advance:- It was observed that this amount includes following Machana advances which are being carried forward from previous years as opening balances at HO level which are not adjusted. Efforts should be made to adjust/ utilize these balances at the Coerd
